STREETS, WATER, SEWER:

County suggested the best long-term solution for some streets is to remove asphalt and return road to gravel for 1-2 years to build a solid base and then 2 layers of gravel with injected oil. If we decide to chip seal we will need to order materials next month. Rick Lau asked about 6-year street plan. Mayor will check with Eljay.
