# APPROVAL OF MINUTES, CLAIMS, PAYROLL:

## **GUESTS:**

Nan Konishi – Palouse to Cascades Trail Coalition – gave update on work/meetings with State Legislature, SEJ Alliance & PCT Coalition. Parks Dept. plans for loose gravel on trail, PCT Coalition recommended hard packed earth. Discussed the RR Trestle to the South of Town. Possibility of having it listed as "Endangered Structure" to try and save it. Looking for local letters of support and letter or resolution from Council in support of the trestle. Would like to submit letters to WA Trust Historic Preservation by March 1, 2020. Council consensus is to provide letter of support. Mayor will draft letter for next council meeting.

## **MISCELLANEOUS:**

RV Parking Ordinance – Discussed changes to Section C regarding the "medical hardship" terminology. Mayor will discuss with Town attorney.

Marijuana Ordinance – Discussed results of Survey Monkey on Town website. Council consensus is to pay the \$99.00 for the full results of the survey. Council agrees to not have ordinance banning marijuana businesses within Town limits and instead handle requests on a case-by-case basis.

Lisa Kuehne – Discussed possible grants from Dept. of Commerce for projects, possibly for a 24/7 restroom by the Texaco Station to qualify for signage on 195. Discussed maintenance issues that could arise with a 24/7 restroom facility. Ms. Kuehne handed out grant information and stated that Rachel from SEJ Alliance would be willing to help with grant process.

Bob Hill – Resident would like to build 2-3 small stick frame houses on their lot. Discussed possible water/sewer hook-up issues. Need to look into size/zoning requirements.

Janet Strohl – Discussed plowing issues. Need to plow earlier and use sand on the hills. Mayor will discuss with Public Works Dept. Discussed condition of Town equipment.

**John Hale moved** to adjourn the regular council meeting, **Bob Hill seconded the motion**, the motion passed unanimously. The regular council meeting adjourned at 9:14pm.
