## APPROVAL OF MINUTES, CLAIMS, PAYROLL:

**Bob Hill moved** for approval of the May 26, 2020 minutes and transactions #956-1018 totaling \$54,245.05 **Janet Strohl seconded the motion,** the motion passed unanimously.

**<u>GUESTS:</u>** Tim Ike, Layne Merritt, Bryan Jensen – JUB Engineering -

Tim Ike – Reviewed status of hangar project. Project is out to bid. Had pre-bid meeting with 2 participants 6/9/2020. Bid opening is scheduled for 6/18/2020. Discusses engineer's estimate of \$270,000.00, hopefully bids will come in lower. Town retains right to reject all bids if too high. Discussed option of removing additional earthwork for future hangars to reduce costs. Council consensus is to use Additive Alternate Bid for additional excavation work.

Layne/Bryan – Discussed TIB Whitman Ave project – Full-depth reclamation. Discussed Engineering Design Agreement for the project. Design scheduled to be done by the end of the year with construction going out to bid Spring of 2021. Design costs is covered by TIB Grant, no Town funds will be required. Council will review agreement and vote at next council meeting. Sewer project update – Contract has been signed with Big Sky ID Corp. Construction will begin in mid-July. Contractor is ordering materials & is aware of timeline regarding harvest season.

## AIRPORT:

Resolution #20-03 Authorization for FAA Grant Offer – Mayor read aloud Resolution #20-03 authorizing the Mayor to sign FAA Grant Offer for AIP Project #3-53-0165-011-2020. **Eric Eilertson moved** to approve Resolution #20-03 authorizing Mayor Root to sign FAA Grant Offer for AIP Project #3-53-0165-011-2020 **John Hale seconded the motion**, the motion passed unanimously.

Faunce Air LLC is asking permission to place a 5<sup>th</sup>-wheel trailer at the airport for use as a temporary office. The Mayor spoke with Karen Miles at the FAA.
