John Goyke moved to approve the April 26, 2022 minutes and transactions #729-739 totaling \$13,851.14 **Judith Littleton seconded the motion**, the motion passed unanimously.

DOE project update:

Paving will begin this week into the following week.

Present Pay App #5 for work completed through 5/7/22 in the amount of \$463,532.14.

Ecology grant covers \$445,674.69 (base bid items), the remaining \$17,857.45 will come from Ecology loan, ARPA funds or Water/Sewer Cap Imp funds.

John Goyke moved to approve Pay App #5 to S & L Underground in the amount of \$463,532.14 using Using \$445,674.69 in Ecology grant funding and \$17,857.45 from American Rescue Funding **Eric Eilertson seconded the motion**, the motion passed unanimously.

Presented Change Order #6 in the amount of \$42,005.47 for drop connection at MH #76, water service line replacement in sleeve and replace leaking valve and lead joint tee. **John Goyke moved** to approve Change Order #6 in the amount of \$42,005.47 with Water Capital Imp Fund being used for water related items, **Eric Eilertson seconded the motion**, the motion passed unanimously.

Unmarked culvert on Eight St, between Summit and Hurd – plugged with dirt, does not daylight. Discussed several options. **John Goyke moved** to replace culvert at corrected elevations using money from the Street Fund **Eric Eilertson seconded the motion**, the motion passed unanimously.

Discussed total project funding. Using 55,000.00 from Town funds overall would keep cost of project within the current utility rates.

JUB will schedule final walk through for feedback and hydroseeding. Will inform council of date and time. JUB will do summary and the end of the project.

Equipment Shop – Working on design. Plans are ready to review with Jacob Billington. Bid will most likely go out in June.

CDBG Emergency Backup Power – Environmental review for Dept of Commerce needs to be updated due to new requirements. Waiting of Dept of Commerce.
