REGULAR MEETING CALL TO ORDER: 7:30pm

### APPROVAL OF MINUTES, CLAIMS, PAYROLL:

**Eric Eilertson moved** to approve the May 10, 2022 minutes and transactions #788-888 totaling \$36,482.89 **Judith Littleton seconded the motion**, the motion passed unanimously.

DOE project update:

Add Alt 2 work completed. Recommend substantial completion as of May 17, 2022. Completed punch list items except for "as- builts" and 1 year warranty letter. Will follow up on hydroseed if reapplication is necessary. Councilman Goyke asked if Town was given any credit for allowing dirt etc. to be dumped at local site.

Change Order #7 – Cost increased to \$16,897.90 related to addition of catch basin due to gas line. Discussed necessity of replacing culvert once costs increased and the process/problems of giving approval during projects. Discussed issues with communication, planning and oversight. Reviewed funding options for Pay App #6 for next council meeting. Asked JUB to speak with contractor before next pay app regarding possible credit for dumping some material locally. **John Goyke moved** to approve Change Order #7 in the amount of \$33,844.23 with \$16,897.90 paid from Street Fund, \$11,442.80 from Sewer Capital Imp. Fund and \$5,503.53 from Water Capital Imp Fund **Eric Eilertson seconded the motion,** the motion passed with 3 yes and 1 no (John Hale). JUB will have refined figures and summary of project at next meeting. Will pursue savings talk with contractor. Presented graph showing wastewater inflow and infiltration from 2016 to present showing improvements with current project. Presented proposed letter to residents summarizing and explaining asphalt patch vs overlay on current project and presenting opportunity for TIB funding for 7th/8th Street to Whitman Ave.

Equipment Storage/Shop – Advertisement for bids 5/26/22 & 6/1/22. Will open bids on 6/9/22 and present to council at meeting on 6/14/22. JUB will send plan set by email to council and 2 physical copies to Town Hall.
