REGULAR MEETING CALL TO ORDER: 7:30pm

## APPROVAL OF MINUTES, CLAIMS, PAYROLL:

**Eric Eilertson moved** to approve the January 24, 2023 minutes and transactions #180-286 totaling \$127,919.61 **John Goyke seconded the motion**, the motion passed unanimously.

**GUESTS**: Sam Mineer, JUB Engineers -

Water System Emer. Power project – Discussed bid opening, bid tabulation, differences between contractors and previous experience. Recommends awarding project to Power City Electric in the amount of \$469,116.83 (from Dept of Comm. CDBG grant funding of \$511,349.30). Discussed timeline of project and the need to minimize any water "outages". **John Goyke moved** to approve awarding the CDBG Water System Emergency Power project to Power City Electric, Inc in the amount of \$469,116.83 **Judith Littleton seconded the motion**, the motion passed unanimously. Contract amendment - There are additional costs for environmental review in the amount of \$19,600.00 due to Dept of Commerce change of scope (to be paid with grant funding). **John Goyke moved** to approve contract amendment with JUB Engineers for environmental review costs in the amount of \$19,600.00 (CDBG funding) and contract termination date of 12/31/24 **Eric Eilertson seconded the motion**, the motion passed unanimously.

<u>Wastewater O & M Manual Update</u> – JUB can prepare update for cap amount of \$5,000.00 (would probably be closer to \$2,000.00). Discussed items that the EPA is looking for to be included in the manual and whether council would prefer that the Public Works Dept complete the update. Perhaps have JUB send Word document to Public Works Dept to update and see where things are at the next council meeting. **John Goyke moved** to approve \$2,500.00 to JUB Engineers for updates to the Wastewater O & M Manual (with the notation that council is not pleased) **Judith Littleton seconded the motion**, the motion passed with 4 yes and 1 no (John Hale).

<u>DOE Sewer Proj.</u> – Dept of Ecology has sent Amendment for Closeout. No rate change needed for repayment of loan.

<u>On-Call Engineering Srvcs Agreement (2023-2027)</u> - Supplied council with a copy of the agreement for review and Mayor will forward a copy to town attorney for review.
