John Hale - Asked when airport plan would be presented.

Ryan Diamond – Hope to have airport plan at next council meeting. Discussed items currently being addressed by Airport Board, along with various hangar sites and types of construction. Bob Weber has been working on policies and procedures.

# **PUBLIC WORKS:**

Streets – Discussed utilizing volunteers for a Battle Days clean-up day. John Goyke will bring up at Battle Days Committee meeting tomorrow. John Goyke asked if section of sidewalk along Whitman Ave could be corrected by next weekend and offered to help. Public Works will try to address it after fixing waterline they're currently working on. Will have Deputy Clerk post on Facebook for people to tidy up properties.

Water – Motor for one of the wells not working (possibly lightning strike related). Will cost approximately \$4,800.00 to rewind motor and would take about 3 weeks. Cost of new motor is approximately \$3,500.00 but would take about 15 weeks to receive. Public Works Department would like to have current motor rewound and purchase new motor for backup. This would avoid possibility of water restrictions during summer months while waiting for new motor.
