John Goyke said he would clean it. Volunteers who are mowing for the park will bring in gas receipts to City Hall to be reimbursed. Big trash can at the park will not be used.

Mosquito Spraying was brought up and needs to be investigated more to see if the regular guy is still in business.


Title searches are still being addressed.


