CALL TO ORDER: 7:30pm

Water – Resident hit Avista gas line while digging up their water line. Public Works handled the locate.

Streets – Street levy resolution due to county by August 5th 2025. Discussed public outreach, newsletter, and the need to emphasize the importance of voting. **John Goyke moved** to run 2025 Street Levy in the amount of \$50,000.00 with specific items to include in resolution at the next council meeting **Ryan Diamond seconded the motion**, the motion passed unanimously.

Sewer – Lagoon will need to be dredged within the next five years. Public Works will look into any possible funding to help cover costs.


Council asked to be kept informed of next Park Board meeting.
